Beca Orgullo de Nuestra Juventud Orlando Official Rules

NO PURCHASE, PAYMENT OR DONATION OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE, PAYMENT OR DONATION WILL NOT INCREASE CHANCES OF WINNING. IN ALL CASES, CONTESTS ARE VOID WHERE PROHIBITED BY LAW.

The Beca Orgullo de Nuestra Juventud Orlando (the "Contest") is designed to encourage eligible youth ("Entrants"), with the written consent their parent/legal guardian ("Legal Guardian"), to use their creativity and achievements to apply for a prize to support their higher education. Judges will choose the winning entries, and prizes will be awarded in accordance with these "Official Rules."

1. SPONSOR INFORMATION:

The Contest is sponsored by Univision Local Media, Inc. with an address at 523 Douglas Ave Altamonte Springs FL 32714 (referred to herein as "Sponsor")

BINDING AGREEMENT: In order to enter the Contest, Entrant and Legal Guardian on their behalf, must agree to the Official Rules. Therefore, Entrant and Legal Guardian (together "You") must please read these Official Rules prior to entry to ensure You understand and agree. You agree that submission of an entry in the Contest constitutes agreement to these Official Rules. You may not submit an entry to the Contest and are not eligible to receive the prizes described in these Official Rules unless You agree to these Official Rules. These Official Rules form a binding legal agreement between You and Sponsor with respect to the Contest.

2. ENTRY INFORMATION:

- a) Entry Period: The Contest will begin on February 17, 2025 at 12am (EST) and end on March 31, 2025 at 11:59pm (EST) ("Entry Period"). Sponsor may, at its own discretion, extend the period of time for the submittal of entries. Any extension of time for the submittal of entries (if any) will be posted on the Contest webpage at www.univision.com/orgulloorlando (the "Contest Site")
- b) Eligibility: The Contest is open to legal residents of Florida residing in Volusia, Orange, Seminole, Osceola, Brevard, Lake, Marion, Flagler, or Sumter County. (except where prohibited) who: are: (i) between the ages of 15 and 18 years on the date of entry; (ii) enrolled as a 12th grade student with sufficient credits to graduate Spring term of 2025; (iii) bilingual and able to write in English and Spanish; and (iv) of Hispanic heritage or affinity. To be eligible to participate in the Contest and/or to win a Prize, any Entrant under the age of 18 must have the permission of their Legal Guardian prior to entry and such entry shall be deemed submitted by the Legal Guardian and shall be treated as if the Legal Guardian had made such entry if chosen as a winner. Entries made by third parties, including, without limitation, persons who are engaged in the development, production, distribution of materials, or drawing of scholarship recipients, are not permitted. By participating in the Contest, Entrant and Legal Guardian agree to be bound by these Official Rules, release Sponsor and any affiliates against all claims, injuries, or damage arising out of any participation in these Contest and redemption of the prize and acknowledge compliance with these Official Rules.

3. CONTEST OVERVIEW AND PRIZE INFORMATION:

- a) How to Enter: NO PURCHASE NECESSARY TO ENTER OR WIN. To enter the Contest, Entrants must send:
 - i. One (1) copy of a school-certified cumulative report card for the Entrant;
 - ii. One (1) copy of these Official rules with Entrant's name, home address, date of birth, email address, and phone number, and signed by Entrant. If Entrant is under 18 years of age upon entry, Entrant's Legal Guardian must provide their name, home address, date of birth, email address, and signature and write "I APPROVE THIS ENTRY" adjacent thereto;
 - iii. One (1) photograph of Entrant;
 - iv. One (1) Student Essay, which must be written by the Entrant, typewritten and double spaced on one 8.5 x 11 sheet of paper and explain educational and professional goals of Entrant, community outreach efforts and/or any personal achievement Entrant has reached. Entrant may include any athletic or extracurricular goals and successes; and

v. One (1) Teacher Recommendation. The recommendation must be prepared by one of Entrant's current or former teachers or counselors, typewritten and double spaced on one 8.5 X 11 sheet of paper and explain why he/she is recommending the Entrant,

via First Class Mail through the United States Postal Service no later than March 31, 2025 to: **Beca Liga de Campeones Orlando 523 Douglas Ave. Altamonte Springs, FL. 32741** Faxes and certified or registered mail submissions will not be accepted.

If the Entry is not completed by Entrant and (as applicable) Legal Guardian, Entrants are not eligible to participate or win. Sponsor withholds the right to not use Entrant's Entry if Entrants do not comply with these Official Rules:

- i. One entry per Entrant. Entries may only be submitted by a single Entrant. Group Entries will not be accepted. By entering, You represent and warrant that You have obtained all of the rights, licenses, and permissions in writing from any person (or Legal Guardian if person is a minor) who may have helped create or who may appear in the Entry and for any material or elements that are not owned by You, and/or which are subject to the rights of third parties prior to the submission of the Entry; and that Your Entry conforms to these Rules. You must provide all written permissions upon Sponsor's request.
- ii. Each essay shall be the Entrants original work and ideas, and will not be accepted or eligible if they include any content that contains or appears to contain:
- · Explicitly profane or obscene material;
- · Endorsement (or condones) illegal drug use, alcohol abuse or other illegal activity;
- · Profanity or extreme or gratuitous violence; language will be evaluated by Sponsor based on context or societal acceptability;
- · Any express or implied commercial endorsement;
- · Any derogatory characterization of any person or group based on age race, color, gender, gender identity and expression, sexual orientation, religious beliefs, marital status, mental or physical disability, citizenship, creed, national origin, physical appearance or political affiliation;
- · Depictions of any conduct, language or other context deemed inappropriate by Sponsor or any of the judges; and
- · Any real or perceived copying or infringement of another's intellectual property rights.
- b) Determination of Winner: At or around April1, 2025 (EST) an internal panel of Sponsor judges shall determine the best overall Entry from the pool of validly submitted Entries, based on the following subjective criteria:
 - i. Academic achievements;
 - ii. Extracurricular/community achievements; and
 - iii. Emotional component/ any obstacles Entrant has overcome.

The potential prize winner or their Legal Guardian (as applicable) will be notified by e-mail or telephone using contact information provided or collected at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If a potential winner does not respond within forty-eight (48) hours of the first notification attempt, or if prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize and an alternate winner may be selected. Prizes will be delivered only to an address in Florida. All prize details are at Sponsor's sole discretion. Inclusion in any such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
