PROMOTION DESCRIPTION: QUE RICAS MANZANAS DE EL BUENO LA MALA Y EL FEO promotion (the “Contest”) begins on August 17, 2026, at 6:00 A.M. PST Pacific Standard Time (“PST”) and ends September 25, 2026, at 10:00 A.M. PST., but is available for entry only from Monday through Friday of each week of such period except for weekends and holidays. Entry in the Contest does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Contest, each participant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Univision Radio, Inc., 2323 Bryan Street, Suite 1900, Dallas, TX 75201 (“Sponsor”), which shall be final and binding in all respects.

ELIGIBILITY: Only legal residents of the United States of America (excluding Florida, New York and Rhode Island), over the age of 21 and older at time of entry and who have not won another promotion of Sponsor in the past 30 days. Employees, officers and directors of Sponsor, and their owners, parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies (collectively, the “Promotion Entities”) and each of the foregoing’s immediate family members (spouse, parents, siblings and children and each of their respective spouses, regardless of where they reside), and/or those living in the same household, whether or not related, are ineligible to

Listeners must correctly add the two announced apple quantities and listen for Raul Molinar, El Pelón's on-air cue to call the station's designated contest phone lines. If a participant's call is answered, the participant must provide the correct total number of apples announced for that day.

The first eligible participant whose call is answered and who provides the correct answer will be declared the winner of the available cash prize, beginning at \$1,000. If the participant does not provide the correct answer, no prize will be awarded that day, and the \$1,000 will roll over and be added to the available prize for the next weekday of the Promotion Period. The call-in telephone number, designated caller number (if applicable), and call-in time window will be announced on air.

When the announcer answers an eligible participant's call, the participant will be asked to state the total number of apples announced on-air that day. If the participant provides the correct total, the participant will be deemed a potential winner of the cash prize available for that day, subject to verification of eligibility and compliance with these Official Rules.
